> In August 2013, Don Barnby circulated a petition among residents of our street objecting to the usage changes planned for the building across from Celia's on Spruce and El Camino. We have long been concerned about excess traffic and parking on our street, and I signed that petition with those concerns in mind.

> I have subsequently had further communication with the new owners of that building, as well as with members of the broader community who know the new owners, and have changed my view. As I've learned more about their planned occupancy and usage, and about them as people, I've become comfortable that their usage will not cause a problem for the street. Further, I've come to feel that having an owner-occupied business/practice in that building will be a good thing for the street, since they will share some of our concerns about traffic, parking, safety, appearance, maintenance, and so on.




